All the admitted candidates will be enrolled in the Course, and they will receive a communication from the Secretary Office (Servizio Segreteria Corsi di Laurea e Didattica) with the instructions to confirm their enrollment by making a one-time payment of the registration fee.

The payment of the fee is to be done no later than the 29th of May, 2024:

- the registration fee for the **entire course** is €1,200.00 (one thousand two hundred euros)
- the registration fee for only the **online component** is €400.00 (four hundred euros).

The Secretary Office will send this e-mail to the e-mail address provided in the application form.

Before the beginning of the online part of the Course, scheduled for June the 10th, 2024, all the participants who have confirmed their enrollment will receive an e-mail including all the information and the instructions needed to start the online activities.

Failure to make the payment of the registration fee within the specified period will be considered a withdrawal

from enrollment by the admitted candidate.

The course will be activated only if a sufficient number of participants confirm their enrollment through the

payment of the registration fee.

The activation of the Course will be therefore confirmed by the University on the 30th of May, 2024 with a

notice published on the Course website. We therefore suggest that you do not make any reservations for

the in-person part of the Course until you have received this confirmation.

In the event of the course not being activated, the registration fees already paid will be refunded.

The candidates listed in the tables A and B as "admitted under condition" are admitted to the Course, but

they must provide documents or information missing in their application. Each candidate who has been

admitted under condition will receive an e-mail from altaformazione@unistrapg.it with the instructions to

regularize their position.

Foreign citizens must comply to the norms governing the entry and stay of foreign citizens in Italy;

participants from non EU countries who need a Visa (see https://vistoperitalia.esteri.it/home/en)

must submit a copy of the document to the Secretary Office upon arrival in Perugia for the in-person

component of the Course.
