# Requirements For Incoming Exchange Students

## Academic Profile

- Must be a degree-seeking student at the home university.
- Must be in good academic standing:
  - Undergraduate students with at least a 3.0/4.0 GPA are preferred.
  - Students with lower than a 3.0 GPA will be considered.
- Studying and seeking courses in the academic college or departments that are partners within the specific exchange or academic areas offered by terms of the exchange agreement. Students with flexibility in course selection and academic requirements:
  - Exchange students need to have flexibility in course selection. Students with specific course requirements needed to graduate may not be able to fulfill these requirements while on exchange if the courses needed are not available.
  - Partner university coordinators are asked to confirm that the nominated students have flexibility in course selection during their exchange.

## Finances

- Proof of financial support on the Certificate of Financial Responsibility form. Must show proof of finances for at least the amount listed to receive a J-1 visa.
  - Academic Year 2025/26: \$22,675
  - Fall 2025 only: \$9,913
  - Spring 2026 only: \$10,735

- Official university transcript (scanned copy accepted)

## English Language Level

- Required scores for language proficiency\* (taken within the past 2 years):
  - TOEFL Internet based (IBTOEFL): 80
    - TOEFL iBT "My Best Scores" score and TOEFL Special Home Edition are also accepted. Institutional TOEFL reports are not accepted.
  - DuoLingo Exam: 120
  - International English Language Testing System (IELTS): 6.5
    - IELTS Indicator (test at home) is also accepted.
  - Cambridge C1 Advanced Exam: 180
  - Michigan English Language Assessment Battery (MELAB): 77
  - Pearson Test of English: 55



# Courses Offered and Restrictions

FSU classes may be limited due to high demand from current FSU students. It is important for exchange students to have flexibility in class selection. Students with specific requirements from their home university may not be able to fulfill these requirements while on exchange and must have alternates. Students will be sent a list of classes currently offered classes and suggested for exchange students.

## Class Restrictions for All Exchange Partners

- Classes from the following academic areas are not permitted for exchange students:
  - College of Motion Picture Arts (Film School)
  - College of Medicine
  - College of Nursing
  - College of Music (except classes offered for non-majors)
  - Department of Theatre & Dance
  - College of Business (unless included as part of a multi-unit agreement with College of Business)

## College of Law

- Classes from the College of Law are permitted only if the student is attending from a College of Law exchange partner university.

## Limited-Access Colleges With Restricted Classes

- Other limited-access majors with restricted classes and generally not available:
  - College of Education, Health and Human Sciences
  - College of Criminology
  - College of Entrepreneurship

## Multi-Unit Exchange Agreements

- Students may request classes from the Colleges and Departments (with exception of those listed above) that are part of a “multi-unit agreement” involving specific colleges and/or departments. Some FSU academic departments have restricted courses, particularly at the upper level (3000/4000 levels). Pre-requisite courses may further limit course availability. Students selecting from lower-level (1000/2000-level) courses are more available than upper-level courses.

## College/Department Specific Exchange Agreements

- Courses available to exchange students are limited to the FSU College or Department that initiated the exchange. In some cases, students may also be able to select from lower-level Liberal Studies (1000 or 2000-level) courses on a space-available basis. Upper-level courses (3000 or 4000-level) outside of the specific College or Department initiating the exchange cannot be accommodated.

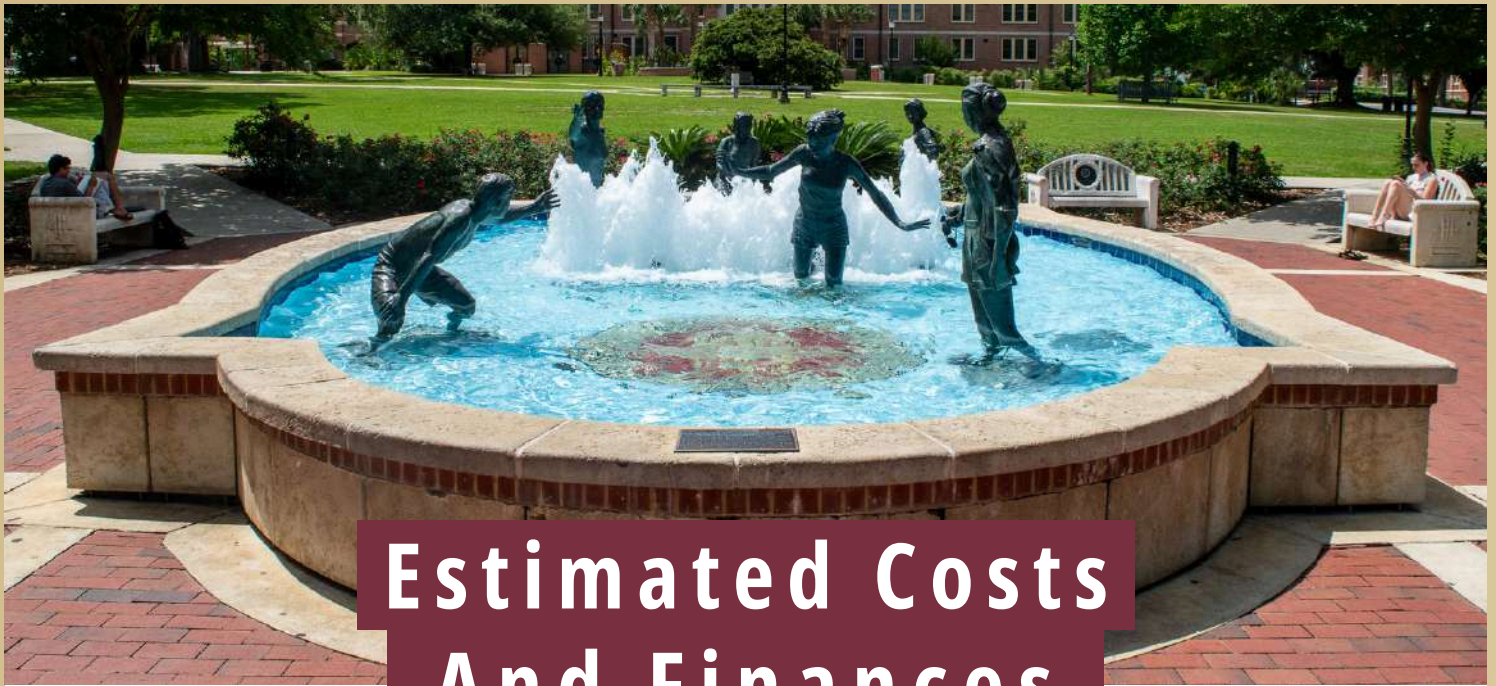

# Estimated Costs And Finances

Students must complete the “Certificate of Financial Responsibility” form before FSU can issue the immigration document (DS-2019) needed for the student visa (called the “J-1 Exchange Visitor” visa). The required minimum funds to show on the Certificate of Financial Responsibility is:

**Academic Year 2025/26: \$22,675 • Fall 2025 only: \$9,913 • Spring 2026 only: \$10,735**

## Estimated Expenses (These figures are average estimates and are subject to increase)

The amount required for the student visa is based on estimated expenses from the following:

- **Tuition:** Paid to home university directly
- **Housing (on-campus):** \$4,100-\$4,500 on average per semester
- **Housing (off-campus):** \$850-1200 per month
- **Food:** \$600-800 per month
- **Books & Supplies:** \$500 per semester
- **Personal Expenses:** \$1,000 per semester
- **FSU Student Health Insurance:** Academic Year: \$3,449; Fall: \$1,313; Spring/Summer: \$2,135 (costs subject to change for 2025-2026)
- **FSU Student ID Card Fee:** \$5 per semester

## Additional Expenses

In addition to the expenses listed above, students should budget for any personal travel during their program as well as for expenses during their 30-day grace period upon the end of their final semester as an exchange student. Many exchange students use that time to pursue travel throughout the US during the grading period. Personal travel is not included in the estimated cost of attendance.

## Visa Information

After admission to FSU and enrolling in the required insurance, the Center for Global Engagement staff will review the student’s financial documentation submitted with the application and will issue the immigration document required for the J-1 visa application (DS-2019). Students will be provided instructions about how to apply for the J-1 visa, which should be done as soon as possible after receiving the electronic form DS-2019.



# Health Insurance and Immunizations

## FSU Health Insurance Plan

Florida State University and the state of Florida, in addition to the US government, have specific requirements for health insurance for J-1, non-degree students. The FSU Student Health Plan offers comprehensive coverage that meets all of these requirements and allows students to use the FSU Student Health Center without paying for the visit and costs upfront. Therefore, it is recommended that international students enroll in the university's approved plan. Students may purchase insurance after receiving notice of admission to FSU and creating an "FSUID" login account.

## Alternative Health Insurance Plan

In addition to the FSU Student Health Plan, an alternative option that meets the FSU/State of Florida/US government requirements is offered by a company named "ISO". Note that a cheaper health insurance plan generally does not mean it offers the same coverage as another plan. It is important to do one's research to make the best choice that meets an individual's needs.

- Note that the ISO plans for 2025-2026 will be available in late Summer 2025. Students should wait to purchase insurance until notified that the new ISO plan is available.

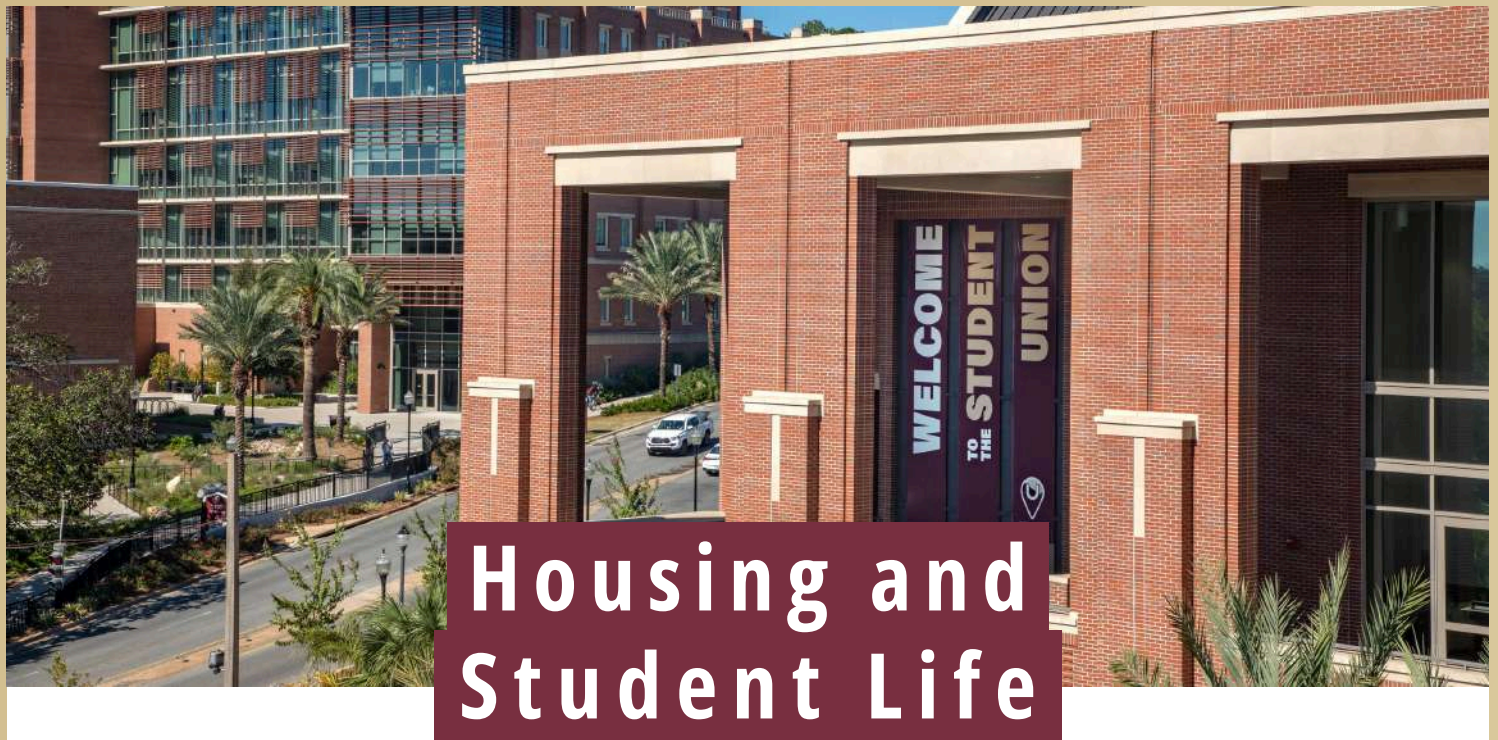
J1 Exchange Health insurance and/or Travel insurance plans from the student's home country do not meet the very specific state requirements for mental health care, and they require students to pay for healthcare services out of pocket and apply for reimbursement, which can cause a significant financial burden during the short study program. Therefore, **only the FSU Student Health Plan or the 2 ISO health insurance plans mentioned above will be accepted. No other insurance plans will be reviewed or accepted to meet this requirement.** Students must submit proof of insurance enrollment after admission to FSU.

## Immunization Requirements

All students are required to submit proof of immunizations before being registered for classes by the Center for Global Engagement. Two combined MMR (Measles, Mumps, Rubella) vaccinations administered after the student's 1st birthday and at least 28 days apart are required. The Immunization Form must be signed by a doctor or clinician.

**Housing and Accommodations**

Student accommodation may be available on campus but is not guaranteed due to high student demand. Students seeking on-campus housing should apply as soon as possible after being formally admitted to FSU. <http://housing.fsu.edu>. Students cannot apply for on-campus housing until after receiving their FSU ID login. A deposit is due within 7 days of a student signing a housing contract. The housing contract cannot be canceled later if a student decides to not live on campus so students should consider their options carefully! Students living on campus are typically assigned a double, shared room. Single rooms are very limited and students wanting single rooms should consider off-campus options. On-campus housing also closes for official university breaks such as Winter Break and Spring Break. Students living on campus need to find alternate accommodations at their own expense.

The “Short Term” housing options section lists apartments offering less than 12-month leases. Off-campus housing may be limited, particularly if only attending FSU for one semester. Furnished apartments may be available but are offered at a higher monthly cost.
